Subject: Adopt FY20 WCSEA Annual Budget

Proposed Action by Board of Education

Adopt the Wilmette Community Special Education Agreement annual budget, as presented in this report, reflecting all anticipated revenues and expenditures for a period extending from July 1, 2019 through June 30, 2020.

Background

In compliance with state statutes, a copy of the school district budget in tentative form has been displayed publicly since May 23, 2019 and a hearing soliciting community comment was held prior to this evening's regular Board of Education meeting. The budget remains tentative and open to change until the Board takes formal action to approve it as the legal budget for fiscal year 2019-20. After formal Board approval, the Administration will file the signed budget with the Regional Office of Education and with the Illinois State Board of Education prior to September 30th, thereby bringing the budgeting process to a close.

Recommendation

The Administration recommends adoption of the final legal budget as proposed.
