(105 ILCS 5/1-20.12b). I understand that if the information above is determined to be false or misleading, resulting in the student named above to not be legally entitled to attend Wilmette Public Schools, District 39, the school district will take legal action to recoup valid tuition charges and legal fees, which will be my responsibility.
